PURPOSE OF THE CONSULTATION

At the request of the Borough of Pierrefonds-Roxboro, the Office de consultation publique de Montréal (OCPM) will hold hearings on the following draft by-laws:

Draft by-law modifying Chapter 18 of Ville de Montréal Planning Programme concerning Pierrefonds/Senneville Borough in order to create a Chapter for the Borough of Pierrefonds-Roxboro and to make sizeable modifications hereof.

Concordance first draft by-law 1047-204 is to modify the planning programme to ensure its conformity with Ville de Montréal Planning Programme, Chapter of the Borough of Pierrefonds-Roxboro.

Concordance draft by-law 1109-41 amending by-law 1109 on the production of site planning and architectural integration programmes.

The course of public consultations will be as follows:

- Description of the draft by-law followed by a question period;
- Hearing of opinions from persons and organisms who wish to express themselves on the project.

Its aim is to perform public consultation mandates in relation with the different jurisdictions for the City of Montréal, particularly, urban projects and developments or such projects as set out by the executive committee or the council.
